From the perusal of the order dated 09.06.2021 it appears that Company Appeal (AT)(Insolvency) No.644/2019 has been filed on behalf of Mr. Darshan Gandhi, ex-Director, Lok Housing & Construction Ltd. Further Company Appeal (AT)(Insolvency) No.79/2021 has also been filed on behalf of Mr. Darshan Gandhi and Contempt Application No.10/2021has also been filed by Mr. Darshan Gandhi and in all these two appeals and contempt application, Learned senior counsel Mr. Krishnendu Datta assisted by Ms Megha Tyagi, Advocate appears on behalf of the appellant.

In all the three matters, learned counsel Mr. Pulkit Sharma appears on behalf of USV Pvt Ltd, financial creditor, Respondent No.1.

In terms of the order dated 9.6.2021, the Financial Creditor/Respondent No.1 has filed the hard copy of the reply affidavit and also reply affidavit on behalf of the Respondent No.2, M/s Lok Housing and Construction Ltd through IRP has been filed which is taken on record.

From the perusal of the order dated 9.6.2021 it appears that the office was directed to comply the order dated 9th Ap;ril, 2021 under the direction in Para 13 thereof and give specific office Note as to whether replies in all four IAs namely IA No.2106/2019, 2609/2019, 2614/2019 and 4316 of 2019 have been filed or not.

An IA No.4316 of 2019 has been filed on behalf of Hitesh Ramji Javeri, Harsha Javeri, Ami Javeri and Mitali Javeri stating in para 1 of the Intervention Application that the applicants are the shareholders of Respondent No.2 and the applicants are 4.92% of the total paid up share

capital of the Corporate Debtor constituting 23,00,000 equity shares. Reply affidavit of the Appellant to the Intervention application being IA No.4316 of 2019 has been filed vide Diary No.27244 dated 11.6.2021 which is taken on record.

Further IA Application bearing No.2609/2019 have been filed in Company Appeal (AT)(Insolvency) no. 644/2019 on behalf of M/s Trade Tech, a partnership firm registered under the Indian Partnership Act, 1932 having its office at A/24, Shreyas Industrial Estate, Off W.E. Highway, Goregaon (W) Mumbai. Reply to this Intervention Application have been filed on behalf of the appellant in Company Appeal (AT)(Insolvency) No.644/2019 which is taken on record.

Further IA Application bearing No.2614/2019 have been filed in Company Appeal (AT)(Insolvency) no. 644/2019 on behalf of M/s Lok Everest Cooperative Housing Society Ltd. which is taken on record.

The Office Note dated 5.8.2021 given by Mr.NL reveals that reply affidavit to IA No.2660/2019 filed by M/s Accel Realtors Pvt Ltd, has been filed on 11.6.2021. Office Note further reveals that reply to IA No.4.316/2019 has been filed on behalf of the appellant on 11.6.2021. Reply affidavit to IA No.2609/2019 has been filed by the appellant. Hard copy of the Written submissions on behalf of the SBI has been filed which is taken on record. Written submissions on behalf of the applicant Mr Hitesh ramjet Javeri and others has been filed on 20.3.2021. Written submissions on behalf of the appellant has been filed on 26.2.2021 vide Diary No.25735. Written
